*修課規定:

- 1. 最低畢業學分數: 36 學分 (含碩士論文 6 學分)。
- 2. 必修學分應全部修習及格。
- 3. 本校財經學院各系碩士班所開設之英語授課課程,視為本學程之選修學分,修習及採計學分數均不設限。
- 4. 學生應具備相當於雅思寫作 6 之英文寫作能力,始得展開畢業論文撰寫程序。修習「英文商務文件寫作」(一)且成績 及格者,視同達於前述認定標準。學生亦得自行參加校外檢定並申請採認。
- 5. 校外實習課每一學分為實習 80 小時以上,實習辦法另訂之。
- 6. 標示為「全英語授課」之課程,上課 100%以英語進行。「英語授課」之課程,得視需要彈性使用中文輔助。
- 7. 選修課程(含必選)得視情形調整上課之學期或停開,亦得經各級課程委員會通過後增開。
- 8. 貿易實務與談判專題研討(一)與(二)為相互獨立之課程,無修習先後順序。
- 9. 依本校「國立臺北商業大學研究生學術倫理教育實施要點」須完成學術倫理教育課程 6 小時,始得申請論文學位考試。
- 10. 研究專題實習、教學專業實習、教育專業實習均不計入畢業最低總學分數。
- 11. 針對<u>入學前非於本國大學主修法律之學生</u>進行基礎補強,不計入畢業最低總學分數。大學階段曾修習法律學分合計達 10 學分且成績均達 80 分以上者,得申請減修一門或改修指定科目一門替代<u>入學前曾於本國法律科系畢業者不得修習</u> (不含輔系)。除境外生外,基礎選修科目未獲准免修或減修者,應全部修習通過始能畢業。
- 12. 與國際學程合開。
- 13. 除本學院各碩士班開設之英語授課課程外,學生經事先同意得修習本校各系或他校所開碩士班課程,以採計 6學分為限。
- 14. 與博士班合開;英文教材為主
- 15. 公部門實習預備課程。
- 16. 至少 320 小時 (二下);校外實習(三)針對復學生、延畢生開設,已修校外實習(二)者不得重複修習。
- 17. 科技部、產學合作計畫助理
- 18. 教學輔助實習生
- 19. 教育部、經濟部、勞動部或其他專案計畫助理

*Annotation:

- 1. Minimum credits required for graduation: 38; including 6 credits of degree essay.
- 2. Students must take all compulsory courses and obtain all credits thereof.
- 3. The English-taught courses offered by master's programs in college of business are regarded as elective credits, and there is no limit on the credits for study and calculation.
- 4. Students must possess English-writing ability equivalent to IELTS 6.0 in writing before they are allowed to commence writing-up of their graduation dissertation. Those who enroll in and pass the course of "Writing Business Documents in English" will be deemed to satisfy the aforementioned criterion. Students who attend off-campus English competency assessment and satisfy the aforementioned criterion can apply for permission to write up their dissertation.
- 5. For each credit of the internship course, students must spend at least 80 hours in practice, subject of the Internship Regulation.
- 6. Courses marked as "taught fully in English" must be lectured fully in English. Chinese may be used in a supplementary manner in courses marked "taught in English" if deemed necessary.
- 7. The elective courses (including Core optional) may be rescheduled to a different semester or suspended. New elective courses may be added if approved by the Curriculum Committee.

- 8. The courses of "Discussions in Practical Trade and Negotiation Issues (I) to (IV) are independent from each other. No sequential order is required for students to take these courses.
- 9. According to NTUB's 'Regulation of Academic Ethics Education for Postgraduate Students', students must complete the 6 hours course of "Academic Ethics Education" before applying for degree essay examination.
- 10. Credits from the courses of "Practice in Selected Research Topics", "Professional Teaching Practice" and "Practice of Educational Case Study" are not counted towards the minimum graduation credits.
- 11. The basic elective courses are prerequisite courses for students who had not studied law in domestic university before they are enrolled into this Program. The credits from these courses are not counted towards the minimum graduation credits. Students with a domestic undergraduate law degree are not allowed to take the basic elective courses. Students (except foreign students) who are not exempted from the basic elective courses must enroll in and pass these courses in order to be eligible for graduation.
- 12. Joint lecture with master program in the Department of International Business.
- 13. Except courses taught in English offered by master's programs in college of business can be taken without limitation, Subject to preapproval by this program, students may take courses offered by other departments. Up to 6 credits may be recognized.
- 14. Joint lecture with PhD program; Taught primarily with teaching materials in English.
- 15. Preparatory course for internship program in the public sector.
- 16. At least 320 hours during the second semester of the second year. Internship (III) is for returning students and students with extended study periods only; students who have already enrolled in Internship (II) are not eligible for this course.
- 17. For assistants of MOST and academic-industry cooperation projects.
- 18. For intern of teaching assistance.
- 19. For assistants of MOT, MOEA, MOL or other governmental projects
