Course Details

This course will be held at the Center for Public and Business Administration Education, National Yang Ming Chiao Tung University (NYCU) on Saturday, **23 July 2022** from 9 am to 5 pm. It will be conducted in English, followed by an **online assessment**, also in English, for your completion within 28 days after the course.

- The assessment comprises 60 multiple choice questions derived from the content of the course workbook.



- You will be given log-in and password details to access the assessment.
- When you log in, you will find instructions on how to work through the assessment.
- There will be a short practice test for you to experiment with before you begin the actual assessment.
- You will have up to three attempts to take and pass the assessment. Your result will be displayed immediately upon completion of the assessment.
- On passing the assessment, you will be invited to print your own certificate. You can then apply for ACI Arb (Associate membership of CI Arb) and consider progressing further along CI Arb's international arbitration training pathway.

Prerequisites

Although there are no entry requirements, candidates should be proficient in both written and spoken English. Where English is not a candidate's first language, it is recommended that they have achieved a standard that is, as a minimum, equivalent to the International English Language Testing System (IELTS) level 7 or a score of 94-101 in the Test of English as a Foreign Language (TOEFL) system. CI Arb issues this advice as a guideline and, while it will not require any evidence of this standard prior to enrollment on a course, candidates who do not have this standard of English may be disadvantaged.

Course Topics

1. Essential features of international arbitration.
2. Laws and rules of arbitration.
3. Composition of an arbitral tribunal.
4. Powers and jurisdiction of an arbitral tribunal.
5. Pleadings (statements of claims and defence).
6. Organising arbitral proceedings.
7. Hearings.
8. Costs and interest.
9. Decision-making process and award-making.
10. Recognition and enforcement of arbitral awards.
